IV. Updates and Action Items

A. DCF Discussion

- 1. Families First Prevention Services Act
 - A. General Update: Compass training starts next week. Will open up more slots as available. DCF will want Director involvement regarding developing community conversations. Looking at complex needs kids and how we can bring them back in State. Improving website weekly. Funding a lived experience position and making an offer to a candidate. QRTP legislation passed both Senate and House; waiting for Governor's signature. DCF will then start with rule making.

- A. Discussion of feedback and comments: DCF making edits based on our past feedback and comments. Anyone can make a complaint, but the intent of the memo is to clarify who can make a formal grievance and what are grievance able issues. Challenge because nothing in statutes regarding who can file a grievance. DCF legal counsel was not comfortable with defining any more clearly who can or cannot file a formal grievance. Defining it any further than "direct involvement in the case" could cause more issues. Likewise regarding grievance able issues. Final memo should be coming out in June. Difficult to make comparisons given TRA regions began through a phased approach. TRAs solely paid through federal Chafee funds.

- 5. Discuss QRTP requirements around extended placements
 - A. Overview/background, high level policy direction, and agreement on how to proceed with next steps: Email from the feds says County Directors could sign off on extended placements at QRTPs, but law says the State Director needs to approve them. DCF looking for WCHSA input. Concerned about workload, yet extended placements is a state-wide issue. Whatever process is decided on, attempt to make it less cumbersome.

6. Other Updates:

- A. ICWA/Counties/DCF OE: DCF will work with PDS to help with logistics of working through initial charter. Incremental process to hopefully ensure success in building collaboration and accomplishing established framework.
- B. Permanency Planning Charter Workgroup Smaller workgroups will bring specific recommendations to larger group, sponsor group, and then PAC (hopefully June or July meeting).
- C. Rate Regulation: DCF wondering if WCHSA has any feedback to give that should be added to report?
- D. Work Load/Case Load Study: The next meeting of the workload study advisory committee is on 5/27.
